INSTRUCTIONS

Regulation 58/15 (i) requires any person who receives veal cattle (which includes male dairy calves (bob calves) up to 150 pounds started or preconditioned intact male dairy cows up to 450 pounds) to deduct the licence fees payable to the VFO by the person from whom the veal cattle is received and to forward the licence fees to the VFO by the **15th of the month**.

These charts are for **private treaty sales** (farmer to farmer) not calves purchased from the sale barns or licensed dealers (who are remitting). They are designed to help those veal producers who have not remitted monthly to get caught up and in compliance with the regulations.

Please input the total head per month into the left-hand chart to calculate the total number of head owing. Transfer the number of total head into the right-hand chart and follow instructions to calculate TOTAL LICENCE FEES AND HST PAYABLE TO VFO.
